IMPORTANT INFORMATION WHERE YOU CONTRACT YOUR Apple® iPhone™ 3G TO A TELSTRA iPhone PLAN – SPECIAL CONDITIONS

The Telstra Contract Form (“**Form**”) or The “Phone Plans and Telstra Business Phone Plans – Personal and Company Form” (“**Application Form**”), as applicable, and these terms (“**Special Conditions**”) together form the iPhone Plan.

In these Special Conditions, you acknowledge and agree that:

- (a) a reference to a Phone Plan in the Contract Form or Application Form is a reference to a iPhone Plan in Our Customer Terms (“**OCT**”), and that the iPhone Plan terms within OCT apply to you instead of the Phone Plan terms within OCT;
- (b) the dealer/shop consultant has conveyed the benefits of a Telstra Browsing Pack to you in relation to data charges that may apply to your use of the iPhone 3G;
- (c) use of the iPhone constitutes acceptance of the iPhone Terms and Conditions and other third party Terms and Conditions found in the iPhone box, or at www.apple.com/legal/iphone/us/terms/service_all.html;
- (d) you may be eligible to receive free Wi-Fi access at Telstra Hot Spots subject to the conditions set out in OCT;
- (e) you may be eligible for a credit if you purchased your iPhone 3G in the last 30 days (to find out more, see www.telstra.com.au/nextgnetwork/pdf/rebate.pdf);
- (f) you may be required to pay an unlocking fee of \$150 to us if you want your iPhone 3G handset to be unlocked from Telstra; and
- (g) the Early Termination Charges (“**ETC**”) will apply to your selected iPhone Plan are:
